over any real or perceived cost savings.

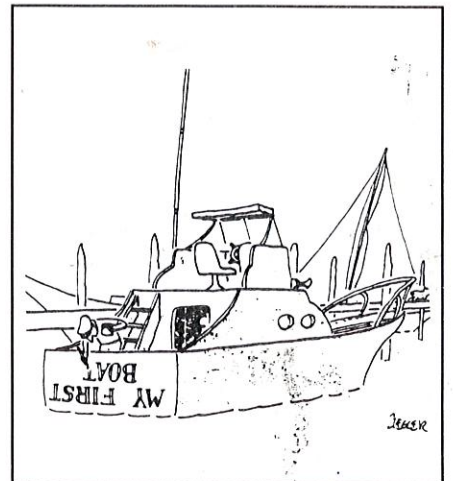

We have started to review specific areas and will have a prioritized completion list before my term expires.

Don't forget to submit a float plan when family or friends are going to use your vessel if you are not in attendance. Mini-Twelve Small Boat News

As most of you know, there has not been an active small boat fleet (outside of the Cape Cod Frosties which primarily sail in the late fall) at the EYC for a number of years. There are nine Club members who have made an effort to change this through the formation of an "ILLUSION" fleet. These boats have been purchased primarily for use as a one-design racer with a semi-formal series scheduled for the late spring through early autumn. Races are to be held on Monday evenings following a 2-week on, 1-week off format. Since the boats are big enough to safely race in the bay, yet small enough to only require a short race course, most sailing will be done to the west of the Club breakwall. There is a long distance race that starts at the EYC and goes to Litton and back to add a little variety to the racing.

The type of boat being pure one-design coupled with the fact that the boat is affordable to maintain (complete set of sails is \$300 and that includes spinnaker) as well as being able to go boat-racing without a lot of hassle promises to make the ILLUSION fleet fun and enjoyable for all involved. Stop by the drysail area in mid-May and you should see nine mini-twelves lined up in a row. If you see nine empty cradles, look for the boats sailing outside the breakwall. If you ask, you can probably take one for a sail and find out how much fun it is to sail with your head just above the water, and yet stay dry in complete comfort.

PHRF NEWS!

This year's PHRF fleet will have two new yachts entering the competition. Attorney William Burke has a J-44 being delivered this spring. The J-44 is one of the hottest production racer/cruisers on the market. Word has it that Bill has a commitment from some of the local "hot shots" to help campaign the boat on Lake Erie this year. Jerry Deimel and crew will be sailing a Cook "One-Ton" this year. This is also a very fast boat, and with Jerry's expertise, a worthy competitor.

The race schedule is pretty much a duplicate of last year's with a few exceptions. The Interclub Cruise will include a triangular course on Saturday, June 23rd in Erie with the Dover Race the

following day. At Ron Busse's request we plan to entertain a cruising fleet or main jib class for at least the Erie to Dover race. If you are interested in entering please contact Ron or myself.

The other exception to the schedule is the addition of the Lake Erie Race. This race was dropped in 1981 due to lack of interest. Buffalo sailor Jim Whistler has worked diligently to promote this year's race and promises over 50 PHRF entries. The race is from Buffalo to Toledo starting June 30th. Diablo, Killary and Andicapp are some of the EYC boats considering the event.

Aires will be campaigned again on Lake Erie. She is on her way back from the Palmer-Johnson yard

on Lake Michigan where she was repaired and upgraded. Best of luck to Jim McBrier and crew with their very busy racing schedule. Aires races in some of the major Great Lakes yacht racing events representing the Erie Yacht Club.
