Thanks to the more than 300 EYC members who shared their valuable time to attend the three (3) Town Hall meetings held this past August! The full breadth of our membership was well represented including participants from Regular, Associate, Senior, Junior and Non-Resident classes. Attendees were presented a detailed status of our club house physical plant, conceptual renovation designs, and financial planning. An "Open mike" feedback forum allowed all attendees a chance to offer comments and each meeting concluded with a "straw poll" to gauge support of the planning. Results of this polling found that there was very strong support to move forward with club house renovations.

Our Chef's "office" is now basically a cage in the storage room.



This article is intended to provide details to those members not able to attend last August's meetings and update all Members on the next steps in the renovation planning.

Why is a major renovation project being considered?

The current Erie Yacht Club House was built in the 1967 and is now 54 years old. It has been 15 years since any major work was done at the Club and most of its key infrastructure has not been changed in the past 54 years. Areas of concern include:

• Galley (aka Kitchen) - The kitchen was initially designed to serve limited social events in the Ball room. Today, it services events in the Ball Room PLUS a full-time Grill room PLUS the Outdoor Deck *PLUS* the Bliss Room *PLUS* events at the Lighthouse *PLUS* events at Rickloff Boat House and even on the front lawn.

The membership has tripled in size since the kitchen was built! Our current kitchen is "grandfathered" in code compliance so any changes we make will trigger some major changes needed to meet current codes.

• Bathrooms, Main Floor - Our bathrooms have not changed in 54 years. They are undersized (too few stalls) and do not meet ADA (wheelchair) requirements.

Like the Kitchen, our Bathrooms are "grandfathered" code compliant so any changes we make trigger some major changes needed to meet current codes. In addition, we know there is leakage/structural damage that needs to be addressed.

· Staff Accommodations - In the past 54 years the Club has grown to include a number of professional staff and we simply do not have suitable office space for them. Computers and other Tech devices need suitable space and adequate climate control. Hourly staff members need a suitable change area.

- Safety Systems do not meet current code - Any work to the Club will trigger the need to install sprinklers throughout the Club. The Electrical system needs major updating and the alarm system is outdated.
- Aging Infrastructure 80% of our plumbing dates back to 1967 and is undersized for the current operational demands. Major subsystems have reached the end of their projected life cycle... including HVAC and Roofing. The West foundation of the club house is leaking and needs to be refurbished. And there is a lack of adequate storage space.

What planning has occurred to address these needs?

In 2015 a survey of EYC membership ranked Club House renovation as the #1 priority. Shortly thereafter, the EYC Long Range Planning Committee commenced planning for a major club house renovation.

A brief recap of these efforts is as follows:

2016 EYC staff interviews

Detailed interviews were conducted with EYC staff to identify problem areas, define possible solutions, and identify ways to improve EYC Member use of the club house.

2017 Architect/Engineering Design reviews

After interviewing 4 potential candidates, a local Architectural/ Engineering firm was selected to evaluate possible approaches of renovation to the EYC Club House.

This included:

- Build new club house
- Keep the existing club house operational while building a fully new structure
- Cost of this option was highest among all options considered and siting of the new building resulted in a less than preferable location of this new building...



- Add second story to existing 2018 "Refocus" planning efforts club house

- EYC legend was the existing club house was designed to have a future second story. Analysis by structural engineers found this not to be true.
- This option was the second most expensive option...
- Retain single story and reconfigure; relocate galley to optimize work flow.
- The goal of this option was to place the kitchen in the optimal location for club house operations... ie. near the center of the club.
- To make this functional, a portion of the kitchen operation would be located in the basement and the logistics of supplying the kitchen became problematic... eg. placing a loading dock near the kitchen was not possible..
- · Cost for this alternative was very high as well...

This study work was important as it refocused LRPC (Long Range Planning Committee) on a path that would keep the kitchen in its current location and focus on improving club house space.

With study work of 2017 in hand, the committee refocused on adapting the existing club in a single floor concept with the kitchen and restrooms in their existing locations. Key Objectives are also defined to include:

- "Right Size" the Club House
- All renovation plans would be based on the current membership
- Expansion plans were to address known "bottlenecks"
 - Increase Galley (kitchen) by
 - Increase Grill Room by +50%
 - Increase outdoor seating by +75%
- Allow for "future enhancements"
 - Design any expansion with capability to add future second floor
 - Design any expansion with excavated basement for storage

2019/20 Covid, lessons learned


The pandemic once again provided an opportunity to sharpen our planning efforts... Lessons learned included:

- Improved outdoor dining experience is needed
- Increased capacity for outdoor dining is required.
- Indoor space needs to be flexible to accommodate many function types

This resulted in the following changes to the design:

- Existing deck to be replaced with at-grade patio with 75% more seating. Lawn seating will still be offered.
- New lower tier seating in Grill room expansion to have Glass partitions and open air features to permit "open air dining" during favorable weather
- Upper Grill east wall to have movable partitions to allow flexible increase of Grill room space...

Floor plans were updated and new budget costs were developed. EYC Finance committee was charged with crafting a plan to pay for the renovation.



2021 Introducing the plan to EYC Membership...

Based on input from the Bridge and Board it was decided to present the plan in 3 Tiers: "Must Do", "Should Do", and "Would Like to Do"

TIER 1: MUST DO

- Expand the Kitchen size by 100%, and Update the equipment.
- Update the Main Bathrooms and increase the number of stalls.
- Relocate the Showers/Lockers and Laundry out of the building and out of prime floor space.
- Expand and consolidate the Office Area
- Update Utilities that are at the end of their life cycle: Plumbing, HVAC, Electrical and Safety (Add sprinklers and update alarms)
- Update the Roof
- Repair the Basement West Wall leak

TIER 2: SHOULD DO


- Expand the Grill Room by 50%. This will be done with an addition on the west side of the club that will include a seating area to the west of the bar, and more Tiered seating at a lower level to the west, like we currently have to the north. This will create flexible space options with windows that can be opened in the new Tiered area, and doors that can be closed for the slower winter months to make it more intimate and cozy.
- Relocate the Hostess stand to the west side of the Grill Room to eliminate a major congestion area. Members and the wait staff have been bumping into each other there for years!
- Add a family rest room, which is a requirement we currently don't fulfill.

- Add a Meeting / Library Room that can also be used as a Bride dressing area.
- Add more basement storage under the addition that will be full height rather than the low height we have elsewhere.
- Increase the Outdoor Seating area by 75% with a new grade-level patio on the north and west sides of the Clubhouse.
- Add a new West Entrance that will have ADA access, space for a future elevator, and improve the facade of the building so it looks less like a shopping plaza.
- Update the main entrance to enhance the facade.
- Refresh interior spaces with new lighting, woodwork, wallpaper, paint and carpets.
- Replace the wall between the grill room and ballroom with a moveable wall to give us more flexibility to expand the grill room or the ballroom as needed.

TIER 3: WOULD LIKE TO DO

- Add a Second Floor over the new west addition for a "Crows Nest" bar and observation area. This triggers the need to add an elevator for ADA access to the second floor, and down to the new basement storage area.
- Add a patio north of the Bliss Room that expands an event in the Bliss Room with an outdoor space.
 This will be at a low level in order to maintain the views from the Bliss Room.
- Add new parking areas because sometimes it is difficult to find a parking space. This can be done east of the clubhouse and along the south fence.
- Add "green space" in the main parking lot to eliminate the "shopping mall look".

LET'S LOOK AT THE FLOOR PLANS AND RENDERINGS...



Here is a look at plans. The green line outlines the existing club house, and the slanted line areas are the expansions. You can see the large 40 foot Expansion to the west which will include a full basement. The Clubhouse is also expanding to the south by 8 feet, which will still give us room for some planters in the front. And the kitchen is expanding to the east and south.

Now let's walk inside...

Go in through the main entrance, and you can see the much larger


kitchen on the right. Look left, and you see a reception desk, the EYC store, and the offices are now all grouped together. Turn left down the corridor, and check out how many stalls and sinks are in the bathrooms. This will now accommodate our current membership size.

Next you see the Family bathroom, and the new Meeting/Library/Bridal room. Keep going to the new west entrance. You are now in the new addition. Walk in to see the host-

ess stand on your right, away from traffic. There is additional seating ahead, and the new lower grill room wrapping around.

Take a right and you will be in the grill room/ ballroom with a moveable wall that gives us flexibility depending on events. And also check out the new patio off of the Bliss Room. Lastly, the bathrooms on the west end have been reduced in size to allow for more storage space.

Three renderings have been produced based on planning to

The first is an exterior view looking northwest toward the entrance of the Club house.

Note the new west entrance and the updated exterior facade.






Second is a view looking south east toward the grill room. Note the new patio seating. While this image shows umbrellas at each table, studies continue on how this patio will be shaded from the sun. The second floor "crow's nest" is also shown in this image.

Third is an interior view looking northwest at the grill room space. You can see the bar remains in place and the new lower tier seating on west side of grill room is shown. Note the image does not show the planned glass partitions separating the lower grill room from upper grill



LOOKS GREAT! BUT HOW MUCH IS THIS GOING TO COST?

Below is a pie chart defining costs for each of the three "Tiers" of work. Notice that the majority of the costs are in the "MUST DO" category.



These are not just construction costs, they are the overall project costs. They include the Architecture/Engineering fees. They include escalation costs such as material cost increases since this is going to be a multi-year project. They include a 10% contingency to cover issues we may discover upon opening things up. They include the cost to relocate the Showers/Lockers/ Laundry to the Canoe House or to a new building. They even include new kitchen equipment, and furniture for the new addition.

WILL THERE BE AN **ASSESSMENT?**

Yes. The amount of assessment will vary by Member class and the scope of work authorized by the membership. Two alternatives will be presented for consideration and vote by EYC membership at this fall's Annual Meeting.

Alternative 1: Full Renovation scope; Tier 1, 2, 3

Based on feedback given during the "straw poll" portion of Town Hall meetings held this past August, the vast majority Members expressed a desire to move forward with all 3 tiers of work scope; ie Tier 1 "Must do", Tier 2 "Should do", and Tier 3 "Like to do". The EYC Bridge and Board endorse doing all three tiers of work based on member feedback from the Meetings.

Estimated project cost is \$8.792 million dollars.

Resolution number 4 defines the project loan requirements for tier 1, 2, 3 work scope.

Resolution number 5 defines the member assessment for tier 1, 2, 3 work scope.

Alternative 2: Limited Renovation scope; Tier 1, 2 only

In the event EYC members vote not to proceed with Full renovation, then the partial renovation plan will be considered; ie Tier 1 "Must do", and Tier 2 "Should do". Tier 3 work scope would not be completed.

Estimated project cost is \$7.481 million.

Resolution number 6 defines the project loan requirements for Tier 1, 2 work scope.

Resolution number 7 defines the member assessment for Tier 1, 2 work scope.

(Note: Resolutions 6 & 7 will only be considered if resolution 4 & 5 are not adopted.)

HOW CAN I HELP?

This is a very large project and it's important that all of EYC Members are vested in this project.

Make your voice heard!... In accordance with EYC Constitution, responsibility for authorization of this project resides with the "Regular" class. "Non-Regular" members are encouraged to make known their recommendations to Regular members.

Regular members are reminded that absentee voting on resolutions is not permitted by the EYC Constitution. You must be present at the EYC annual meeting to vote.

So please come to the meeting, and vote for a great future Club-



Many of you may wonder why the yacht club grounds crew unplugs the electrical connections to boats in the yard nightly, and why don't they plug them back in the next morning?

There is a simple explanation and there is also a bit of urban legend to the reasons why a boat would want to be plugged in all winter. The safety committee has asked me to write an article to help boat owners understand. A disclaimer, I am not an electrical engineer, but I have sought input from an expert Jeff Eastman, who is an accomplished electrical engineer and Jeff has agreed to help us all understand some of the basics of batteries and battery safety.

Jeff is an EYC member who joined in 2013, and whose wife Neala joined 29 years ago. Jeff has a PhD in Electrical Engineering from NC State University. Thank you, Jeff, for your contributions!

So, let's get right to it. The main reason to unplug is safety. When winter storing a boat, it is common to top off the fuel tanks. Full of fuel, the boats are packed together tightly like sardines. A fire on one boat would most assuredly spread quickly to many boats. For this single reason alone the yacht Club prevents a boat from being plugged in, unattended, overnight in the winter. Similarly, it would be irresponsible for a crew member to ever plug a boat in, not knowing what is on the other end of the connection.

I am sure this is no surprise to anyone, so on to the part of the article that addresses the reasons that members have offered as to why they might want their boat plugged in at all in the winter. One of the many reasons given is that a battery will freeze and can be damaged or destroyed, and keeping a trickle charger on the batteries prevents freezing. It is this reason that I want to address.

First some basic facts:

1. A fully charged lead acid battery can handle extremely cold weather. The batteries can withstand temperatures as low as -75 degrees Fahrenheit without freezing. The caveat being a 'fully charged' battery.

2. A fully discharged battery will freeze at about 28 degrees F. So, what is a fully charged battery and what must a boat owner do to ensure that the battery is fully charged? How long will it stay fully charged? For this part of the discussion, I asked Jeff Eastman to lend a hand.

Regarding how to deal with marine batteries in an Erie, PA winter, Jeff writes:

What you have written correlates well with what I have learned over the years about lead-acid storage batteries. These batteries' ability to hold a charge depends upon their internal resistance, which is a function of their age.

This internal resistance causes a small leakage of electrons between the (+) and (-) terminals and causes a fully charged battery to self-discharge on its own over a period of time. The question is, how long?

Wikipedia says:

Self-discharge is a chemical reaction, just as closed-circuit discharge is, and tends to occur more quickly at higher temperatures. Storing batteries at lower temperatures thus reduces the rate of self-discharge and preserves the initial energy stored in the battery. Self-discharge is also thought to be reduced as a passivation layer develops on the electrodes over time.


Other references I've found say they lose 4-6% of their amp-hour capacity per week at 80 degrees, so a 125 amp-hour battery would lose perhaps 6.25 amp-hours per week at 80 degrees. Of course, winter in Erie is more like 15-50 degrees F so the actual self-discharge rate would be less. If the self-discharge rate is 5 amp-hours per week, then the battery will discharge to half capacity (62.5 amp-hour) in about 12 weeks. The freezing point of a 50% discharged lead-acid battery is about -35 degrees F so there's still plenty of safety margin even in Erie. Of course, all this assumes there are not any loads on the battery. If your boat has any devices that remain on after you've turned your battery switches off, then this will accelerate the discharge.

On Northern Lights, I never like to let my batteries below 50% of charge so I try to plug in my battery charger for a day every couple of months while I'm on the hard. I have a Xantrex battery monitor on the boat (which is still on when the switches are off) and I've never seen more than about 15% discharge with this interval so my calculation above is pretty pessimistic.

To summarize, putting your batteries on a trickle charger over the winter is certainly a safe course of action but plugging in your boat's battery charger for a day every few weeks will do just as well.

Regards, Jeff Eastman Well, EYC, there you have it. I hope you get a charge (sorry, I couldn't help myself) out of reading this article as much as I did writing it and learning from Jeff. On behalf of our membership, thank you Jeff for your expertise and willingness to share.

The other day I was sitting in my kitchen and as usual gazing out at the water daydreaming about how lucky I am to have such a delightful view both summer and winter. Just to the left of the daydream window there is a very old chest of drawers that was built by my Great Grandfather Orville Baker (mothers' side). The dresser has a crack in the side and one leg needs a splint but other than that it is very functional and of course the top is a landing zone for "things" that need to be thought about, like put it away or what the heck and I am going to do with this, I would bet you all have such a spot!!

Anyway, there sat two trophies one EYC and one sort of EYC which got me to thinking (again) about where they all come from and what becomes of them when they go out of view. This is the tale of two trophies that have been long since been awarded or given and are now long forgotten.

The first one was removed from the club trophy cases several months ago because it was broken, the lovely silver bowl was separated from the base. The bowl was tarnished, after a little elbow grease and polish the name appeared, The Clarence A. Traphagen Memorial Trophy Penn-Erie Fleet. It was last awarded in 1970, unfortunately this once thriving Star Boat fleet has given way to smaller less expensive boats and the trophy was anchored.

As I read through the names of the champions engraved in it, I thought about the trophy and a flood of wonderful memories came back to me, but one very sad memory raced through my head. Who you say was Clarence A. Traphagen? More commonly known as "Bud". He was the father of P/C Peter Traphagen and my old friends Eric and Mike; Bud was also a very active member of the Club.

Back in the 50's much like today Sea Gull point just outside the channel was a popular place to anchor for swimming, picnics and typical good old fun afternoons on the water. Regrettably, this typical day turned sad, as Mr. Traphagen was getting ready to take a swim he slipped and fell into very shallow water, suffering a broken neck. After this tragic accident friends created and dedicated the memorial trophy in his honor.

Later I researched the club's recorded history and could not find anywhere where this accident had ever been recorded. Now that our LOGs are posted on the internet it makes me feel better knowing Bud's accident is recorded and the incident, while sad will not slip away with a broken trophy. The list of those winning this championship are listed at the end of this article.

On a happier note, the second trophy never actually made it into the Club trophy case, The EYC Twist Championship 1962! If my memory serves me right (sometimes it doesn't) Chubby Checker and his hit song "The Twist" was at the top of the charts and of course everyone had their own "moves". I don't recall the actual theme of the party, but it did include a dance contest and of course it was the Twist that dominated the competition. Competitors came from every dock around, so let the music begin! (On a side note, one of the other things I remember about "The Twist" was many a back were never the same after dancers gave it there all) and "how low could you go" was the cry!!

Ok, long story short, Yours Truly and my dance partner Suzy Zurn got the Blue Flag and the silver plate pictured above was ours! But wait that is only part of the story, the deal was Suzy would keep it at her home for 6 months and then it would be my turn, seemed like a good idea at the time however time has a funny way of throwing things off course. While it was in her anchorage it must have been tucked away and forgotten, "boo hoo!" Wait, here comes the good part, about a year ago almost 60 years later Suzy and I happened to be attending the same memorial service when her daughter Karen said, "don't go anywhere afterwards, Mother has something for you."

You guessed it, back in my court... now all I have to do is remember what date it gets passed back?

If These Docks Could Talk, they would say, "Life deals us all little Twists, what matters it is how we handle them!!"

Transitions are rarely as easy as we hope they are. In the early 2000's, Paula and I retired from racing our 24' foot sloop in the regattas of Wilmette Yacht Club at Wilmette Harbor, Illinois. Although this decision to abandon our weekly competitions was difficult, I didn't miss spinnakers gone awry. Paula appreciated the now-less-colorful language of the skipper.

We moved to a life of cruising and live-aboard vacations on our Horizon 39' cutter, the S/V Nereus. With every intention of completing "the Great Loop" from Lake Michigan and back again via the USA's inland waterways and coastal waters, we encountered mother nature's "slings and arrows of outrageous fortune" bearing the four names of Charley, Frances, Ivan, and Jeanne in 2004. The World Meteorological Organization retired these names, and they will never be used again.

These storms affected the Gulf Coast so severely, our southward journey halted with a detour to a small municipal marina on Roseberry Creek, (Tennessee River's Lake Guntersville), Scottsboro, Alabama. There we were: stuck in bass boat paradise aboard a heavy cruising yacht...

We thought to resume our southward journey the next season after contractors could sufficiently repair gulf-coast marinas to receive visitors. Alas! A tropical depression developed on August 23, 2005, to become the infamous Hurricane Katrina, causing 1,800 deaths and \$125 billion in damage and another name retirement. This "SETBACK" in capital letters meant another year potentially casting for large-mouth bass in fisherman's heaven. There was a silver lining: catching up on the long list of Carl Hiassen's hilarious Florida-based mystery novels.

Eventually, Nereus made her way via the Tombigbee waterway to Dog River Marina. We enjoyed the fine southern cuisine of the Mobile Bay Yacht Club and a slip from which we explored new waters. Straightway, we moved farther east to a barrier isle, Pleasure Island (Orange Beach) Alabama, which is about 24 nautical miles west of Pensacola Bay and Naval Air Station Pensacola.

From that location, we were so delighted to cruise isles, bays, and bayous all along the Gulf Coast between New Orleans and Tampa Bay.

Although the damage to Nereus seemed mostly cosmetic it was evaluated to be a total loss by the insurance company.

All our thoughts of completing the Great Loop vanished. (Aboard our son's Cape Dory 28', we eventually completed another large leg of the Loop sailing offshore from Florida to the Hudson River, New York, eventually to arrive at Lake Erie.)

We only had to survive Ike, Ida, Fay, Gustav, Claudette, Isaac, Karen, Cindy, and Michael. We won't discuss the BP Deep Water Horizon disaster [*].

All was "generally" well, until, as we wrote in the Winter (2021) issue of "The Log", three hours of Hurricane Sally's eyewall destroyed our beloved Nereus' tabernacle, mast, rigging, and brightwork. Even though hull damage was basically cosmetic, the whiskey bottle unbroken and the pipe tobacco dry, our insurer declared her to be a total loss.

What to do next?

After long family discussions, this aging skipper and his wife decided to make another transition. Our next boat would be a motor vessel. No more sails, halvards, sheets, and winches for us! We settled upon a small 21' classic "toy" tugboat manufactured by Ranger Tugs of Washington state, but currently residing on Long Island, New York. She had the same green hull color as her predecessor. A small Yanmar diesel gives her a cruising speed of about 8 knots.

We figured with this boat we could still just be cruisers "slowly going nowhere at great expense" in the summer of 2021. Of course, the boat didn't come with either a tow vehicle or trailer, so more arrangements proved necessary.

As Scots poet Robert Burns noted, "the best laid schemes o' mice an' men gang aft a-gley." The simple replacement of a cutlass bearing, noted in our marine survey of the boat, took nine months for local mechanic(s) on Long Island to accomplish after a January work order - and then only after I secured the appropriate bearing myself and shipped it to them. Long Island's marine mechanics completed the work in August. Finally, we reached our destination of Presque Isle Bay and the EYC - but not until September... Hallelujah!

What we've learned so far in

- No matter the weather, hurricanes seem unlikely in Erie.
- It's quite nice to just "turn a key" and go.
- EYC gatherings are fun!
- A truck with a trailer can carry our little boat far and fast.
- If we give a "toot toot" with the horn from a toy tugboat, people wave and smile.
- We can still have "cruising" parties for up to 8 people.
- Unlike a heavy cruiser, our small vessel moves like a bobbing cork in the water.

- Her shallow draft lets us explore little coves and bays formerly impossible to reach.
- · We try never to take the sea abeam; we don't appreciate that kind of rock and roll.
- We've learned to adjust course to take heavy wakes in the bay bow forward.
- A light boat is more troublesome to dock in a breeze but much easier to anchor.
- The waters of Presque Isle Bay and surrounds are quite lovely for cruising "in season."

If all goes well enough, we hope to enjoy our little tugboat during our remaining active retirement years. Since our last vessel was named for the shape-changing sea god Nereus, we reluctantly refrained from creative and clever puns and stuck to the ancient Greek mythology of her predecessor and mythic ancestor(s).

We've named our little green tug for one of Nereus' many daughters. She will be the "Nērēis Nêsaiê", roughly translated as "dwelling - on - islands Nereid."

Nesaea was one of the Nereids who consoled Thetis' grief over Achilles' loss of Patroclus. Later, she and four of her sisters were able to help the mythic ancestral progenitor, Aeneas, and his crew during a storm, thus becoming a friend of stormtossed sailors. Our semi-tropical Winter mooring will remain a mystery, but at least we won't be chapters in Hiassen's "Assume the Worst" (2018) or "Squeeze Me" (2020).

Who knows? We might complete the Great Loop to Manitowoc, Wisconsin in the future. We look forward to giving everyone a toy tug's cheerful "toot" on Erie's next boating season, 2022.


I wish to thank all those who worked with me the past few years and I welcome the honor of serving you as your Commodore in the year ahead.



"Club employees and temporary employees are ineligible for nomination as Officer or Director, and no Officer or Director may serve as an employee during his or her tenure in office. Persons who are paid by the Club as independent contractors, consultants or as compensation for duties approved by the Board of Directors are not subject to this provision."

Article VIII, Paragraphs 4, 5 and 6 will need to be renumbered 5, 6 and 7, respectively

Rationale:

This change to the Constitution which was approved by the Board in 2020 proposes to eliminate any potential conflict of interest when an employee off the Club would have to recuse themselves from voting on any motion due to their position as an employee.

"Upon written request to the Secretary-Treasurer, the Board of Directors in its sole discretion may approve payment of the Initiation Fee for Regular Members in installments. Remove the following Basin related text from the EYC By-Laws. (removed text shown in blue bold strike out)

1. The annual Membership Fee for Regular Members shall be \$850.00, effective January 1, 2020, (Rev.11/15/19). In addition, each Member shall pay an Initiation Fee of \$4,500.00 upon acceptance, effective January 1, 2004, except that the Initiation Fee for a Regular Member who converts from Special Membership and who is the un-remarried surviving spouse of a deceased Member shall be one third (1/3) of said Initiation Fee. Effective 2002 Regular members who have paid full dockage for the current season will be credited \$50.00 in the September statement. (Rev. 11/16/01. Effective 2006 the \$50.00 credit will be allocated to the Basin Reserve Fund. (Rev. 9/24/2005)

15. Effective November 1, 2005, the Dock Committee shall be directed to increase slip, dock and storage fees by an amount sufficient to generate \$165,400.00 annually. These funds shall be allocated to the Basin Reserve Fund. The dock fee increase will be generated by increasing the dock minimum charge and the square footage charge by the same percentage.

16. Effective November 1, 2005, and expiring on October 31, 2021, all Regular and Associate members will be assessed \$250/year. (Rev. 11/15/2014) All funds collected will be allocated to the Basin Reserve Fund.

Rationale:

Basin debt is paid in full as of 2/1/21. Final phase of basin renewal, the EYC fuel dock/tank replacement, is fully funded and will be completed early spring 2022. As such, all text related to the basin project can now be removed from the EYC By-Laws.


