The member and the Club agree that the member remains solely responsible and agrees to indemnify and hold harmless the Club for any loss, damage or personal injury to the person or property of the member or any guest, employee, agent, servant, independent contractor, or other actual or apparent representative of the member, whether such loss, damage or personal injury be occasioned by fire, theft, Act of God or any other cause of condition, and the member assumes full responsibility for any claim or suit as stated when said member made application for membership. The member accepts the terms of this application and shall abide by all the Docks and Ground rules and regulations now and hereafter in force. Failure to comply will void the application.

The Club reserves the right to utilize the slip when not occupied by the member. The Club may relocate the vessel as may be necessary for the efficient and safe operation of the Club basin. The Club may gain access to the assigned vessel, but shall have no obligation to do so, if necessary to protect the safety of the Club or member's property at the Club's sole discretion.

The member(s) recognizes and accepts that the Club's Dock Committee has the final decision-making power on all matters related to slip assignments.
